This addendum is consistent with the County’s revised grant agreement with FDEP which requires all deliverables to be complete by March 31, 2026.

Except as specifically amended by Attachment A, all other terms and conditions of the Interlocal Agreement between the COUNCIL and COUNTY, as amended, shall remain in full force and effect.
