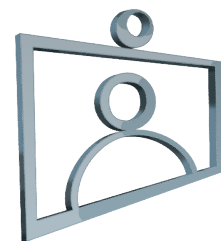

PROPOSED SCOPE OF WORK

The ProMedia Group (PMG) will provide design, engineering, equipment, installation, programming, project management and training for an audiovisual system for the Desoto Courthouse in Arcadia, FL.

2nd Floor Historic Courtroom

System Inputs = 5

- (2) HDMI cables at Judge's Bench. One input will be for the OFE Zoom PC. The second input will be for future use
- HDMI cable at Prosecutor's table (laptop)
- HDMI cable at Defendant's table (laptop)
- HDMI - Document Camera (OFE table 2 left side of judge bench)

- (1) 65" Sony Display (mounted on pole bolted to floor)
65" display width will overlap Judges portion of bench by 2-3 inches

Video Conferencing

There are (2) owner furnished PCs and (2) desktop monitors for videoconferencing. **Only (1) PC will be an input into the AV system** and will be connected to the OFE PTZ camera. The second PC will not be a system input. It will connect to the OFE wide angled camera and the (2) owner furnished desktop monitors. PMG shall mount both PCs at owner's desired located under Judge's bench. PMG will place both PC cameras at the owner's desired location at Judge's bench.

Implementation Plan

PMG estimates approximately 15 days of on-site installation requiring full access to the above-mentioned room(s). Unless otherwise noted, labor rates are calculated based on standard business hours (8 AM – 5 PM, M-F). The pricing and schedules outlined in this proposal assume that PMG can complete the stated Scope of Work without interruption in a single, continuous timeframe. Additional costs may be incurred for multiple mobilizations/demobilizations.

A change in room availability with less than 10 days' notice to PMG may result in additional charges and impact schedules and deadlines.
