Recipient, Desoto County, desires to supplement the original Agreement entered into and executed on January 26th, 2024 as identified above. All provisions in the original Agreement and supplements, if any, remain in effect except as expressly modified by this supplement.

The changes to the Agreement and supplements, if any, are described as follows:

PROJECT DESCRIPTION

Name County Road 760 from US 17 to Southwest Aster Avenue Length 0.270 miles

Termini Five-foot sidewalk on the south side of County Road 760

Description of Work:

The scope of the project consists of the construction of a five-foot sidewalk on the south side of County Road 760 from US 17 to Southwest Aster Avenue. The project will include ADA compliant road crossings with signage and stripping as appropriate.

Reason for Supplement and supporting engineering and/or cost analysis:

The purpose is to provide additional funding to compensate to cover the cost of a pedestrian crossing of the Seminole Gulf Railway tracks. Seminole Gulf Railway requires an \$8,600 agreement preparation fee to continue the review of the County plans. The County has approximately \$6,000 between the amount of the design contract and the LAP agreement. Desoto County has requested additional LAP funding in the amount of \$2,600.00 to cover the shortfall, Two- Thousand Six Hundred Dollars) in federal funds. The total cost of construction is \$79,010 (Seventy-Nine Thousand and Ten Dollars). The total department participation in the project is \$79,010 (Seventy-Nine Thousand and Ten Dollars).

The Local Agency Program Agreement (LAP) is amended as follows:

- A. A. Exhibit "B" SCHEDULE OF FINANCIAL ASSISTANCE is replaced in its entirety by the ADJUSTED EXHIBIT "B" SCHEDULE OF FINACIAL ASSISTANCE" and is incorporated by reference.
- B. Section 4.A under project cost on page 1 of the January 26, 2024, Local Agency Program Agreement is replaced in its entirety by:

The Total cost of this project is \$79,010 (Seventy-Nine Thousand and Ten Dollars).

The amount is based upon the schedule of funding in Exhibit "B", Schedule of Financial Assistance attached to and incorporated in the Agreement. The Agency agrees to bear all expenses in excess of the total cost of the Project and any deficits involved. The schedule of funding may be modified by mutual agreement as provided in paragraph 5.1.


